These teams compete against clubs from other areas of Southeastern Pennsylvania and beyond. Spirit Soccer of Chester County fields up to three teams per age group so that more than just the top level players can have the opportunity to play against other clubs. Some Spirit Soccer Club of Chester County teams have traveled to places such as Dallas, Florida, Phoenix and Sweden. In 2010, over 50 Spirit Soccer Club of Chester County alumni will be playing at the college level.

4b (Code: ) (Expenses \$ 247,506. including grants of \$ ) (Revenue \$ 380,126.) Spirit Soccer Club of Chester County soccer tournament is the largest in Pennsylvania. It attracts teams from throughout the Northeast. Last year over 440 high caliber teams participated, with teams coming from as far south as Virginia, as far west as Ohio, as far north as Canada, and all points in between! We hope your team is one this year. The tournament, for girls and boys U-9 through U-16, occurs over two weekends in August.

4c (Code: ) (Expenses \$ 51,639. including grants of \$ ) (Revenue \$ 47,819.) Programs include the Developmental Program for children ages 4-13. There are over 450 players in this program. For the younger players, it is their first introduction to soccer, they are taught the skills of the game by our very experienced coaching staff, with the help of many parent volunteers and referees.
