

# Usage of S USC Designated Field Complexes

## **Current and Proposed Policy**

Individuals or teams wishing to use Spirit United Soccer Club designated fields may do so according to the following procedures:

## **How To Obtain A Field Permit**

1. An individual or organization may wish to hold a special “game” or “event” during the season. To make planning easier a permit may be granted in advance if available.
2. Individuals must put their request “in writing” to the Spirit United Administrator at least two weeks in advance.
3. The request must be approved by the President before any additional action will be taken.

## **Regulations Governing Field Permits**

- a. Permits must be in possession of a member of your group at the field. They are not transferable. Users must only use the assigned field.
- b. Authorized users must adhere to all local laws and regulations ( including parking). Failure to adhere to those rule may result in withdrawal of field use permit.
- c. Alcohol and smoking is not allowed at any field.
- d. No pets are allowed at the fields
- e. Grilling is not permitted except in designated picnic areas (where applicable).
- f. Fields will be left the way they were found. Trash and recycling receptacles are available at all fields. **Violation of this rule will result in a fine of \$50.00**
- g. Field permit holders and their guests use the fields at their own risk.
- h. In the event of rain, there is no automatic rain date. If you had a special permit we will help you reschedule as best we can.
- i. In the event of inclement weather field permit holders must check Spirit United Soccer Club web site to see if fields are open.
- j. Violation of above regulations will result in the withholding of future permits.

## **Allocation Policies**

Spirit United Soccer Club activities shall have the first priority on the fields at all times. This means that adjustments may be made for S USC postponements, emergencies, playoffs, etc. It is not intended to usurp other uses without appropriate consultation and substitution when possible.

Retail rental usage authorized by S USC shall have the next priority. Functions such as tournaments etc which are fully paid in advance would not be subject to changes due to items listed in items #1.

At the discretion of the Spirit United Board of Directors, factors that will be considered for allocation of field time will be: 1) soccer programs; 2) number of community residents registered

in program; 3) youth program; 4) all inclusive program for participants (no tryouts); 5) non-profit organizations; 6) adult programs 7) all others.

Current certificate of insurance, release and indemnification form must be on file.

If someone notices any problems of abnormalities to the field, they will be requested to notify S USC Administrator.

### **Field Usage Fees**

Field rental is collected by Spirit United Soccer Club to help offset the costs for marking the fields, providing nets, and the better grade fertilizer that is used.

The field usage fees for 2011 are as follows:

Retail Field Rental for 1 game	\$75
Retail Field Rental for 1 day	\$450
Retail Multiple Field Rental for 1 Day	\$400 per field per day

Discounted rates may be available for non-profit community organizations with approval of the Spirit United Soccer Club Board of Directors.

### **Inclement Weather Policy**

- The Spirit United Soccer Club has the right to cancel any field usage when the fields are deemed too wet. The cancellation fee and the field fee will not be charged. When a usage has not been canceled and fields are not in playable condition due to rain, it is the scheduling organizations responsibility to make the determination if the field is usable. Any organization that uses a field that has become unplayable and causes damage will be held financially responsible for the damage.

### **Application Form**

Send email that include date, time, number of people, purpose, and contact person, including address and DAY telephone number In general , only two (2) advance requests per organization can be honored in any calendar year.

The Board of Directors of Spirit United Soccer club has endorsed this policy.
